Dear Sir, Madam,

The Gaming Authority has received your letter dated June 22th 2012, in response to our letter dated June 8th 2012, reference number 00.001.620. The Gaming Authority welcomes your willingness to take into account our prioritisation criteria for the enforcement of illegal games of chance through Internet.

In your letter you confirm that you have taken the necessary measures to ensure your website will not meet our prioritisation criteria. Research, undertaken on July 18th and on July 31th 2012, has shown that your website, [REDACTED], doesn't meet our prioritisation criteria and therefore we will not focus our attention on your website and on your activities at this moment. As written in our previous letter our attention will be focused on offerors of illegal games of chance through Internet, aimed at the Dutch market, that meet (one of) the three prioritisation criteria. These offerors will be faced with the Gaming Authority's enforcement measures.

We appreciate you taking the necessary measures to prevent meeting one of the three prioritisation criteria, in particular those taken after you had been informed of our findings and also those taken concerning the criterion '.nl extension'. I take your remark about this last criterion to heart. As written in our previous letter, the prioritisation criteria may evolve over time but at this moment the Gaming Authority does not see a reason to adjust the criteria. When there are reasons to adjust the prioritisation criteria and the Gaming Authority intends to do so, the Gaming Authority will try to inform you well in advance.

For your information, we did not find a copy of a status report enclosed in your letter, although you mentioned that you had enclosed this. If you would like us to have a copy, you may also send it via email to info@kansspelautoriteit.nl.



The Gaming Authority is keen to build and maintain a constructive relationship with your company and with other companies that show their social responsibility. We therefore, also in light of your request, intend to organize a meeting in the second half of this year to meet with these companies.
